

**TAXATION SECTION  
MINUTES OF ANNUAL MEETING  
(September 25, 2008)**

Council Chairperson, Jay A. Kennedy, called the meeting of the State Bar of Michigan Taxation Section to order on Thursday, September 25, 2008 at 5:00 pm. The meeting was held at Meadowbrook Country Club, Northville, Michigan.

A. MINUTES

The Minutes of the last annual meeting of the Taxation Section held on September 19, 2007, were distributed by the Council Secretary at that time, Ronald T. Charlebois. There being no comments, on motion duly made by Gina M. Torielli and seconded by Warren Widmayer, the minutes were accepted.

B. TREASURER'S REPORT

Council Treasurer, Ronald T. Charlebois, presented the Treasurer's report for the period October 1, 2007 through August 31, 2008. Jess reported that membership in the Section stayed steady for the most part, with membership dues received only slightly less than budgeted. Expenses incurred by the Section were also reported as down for the year. Certain committees did not expend the total amounts budgeted for them. The cash on hand as of the beginning of the fiscal year was \$113,764.09. Revenue increased this amount to \$185,425.88. Total expenses for the fiscal year were represented as \$54,573.29, leaving cash left of \$130,852.59. There being no comments, on motion duly made by Gina M. Torielli and seconded by David Walters, the treasurer's report was accepted.

C. NOMINATION AND ELECTION OF OFFICERS

Jay A. Kennedy, on behalf of Aaron H. Sherbin, Chairperson of the Nominating Committee, announced the results of the Nominating Committee's work. The Nominating Committee comprised of Jay A.
